Staff/Family Scholarships

Donations fund partial scholarships for families who are unable to afford full tuition. This includes scholarships for our teachers and staff so that they can provide their own children the same high quality education as the rest of our families. We currently have 6 staff children enrolled at RSCC through these scholarships thanks to the generosity of our parents!

Our Teachers

The average tenure of our teachers is over 10 years and growing. Nearly 3/4 of our teachers and Directors have been with us for over 5 years. Twenty five of those have been here over a decade, and five have been with us for over 20 years.

Our Facility

Our beautiful School covers over 25,000 sq. ft of classrooms, indoor play space, and outdoor playgrounds. Fundraising has allowed us maintain our facility and to add playground enhancements, security gates, cameras, wi-fi and classroom technology, bathroom renovations, and ceiling fans for improved ventilation during COVID.

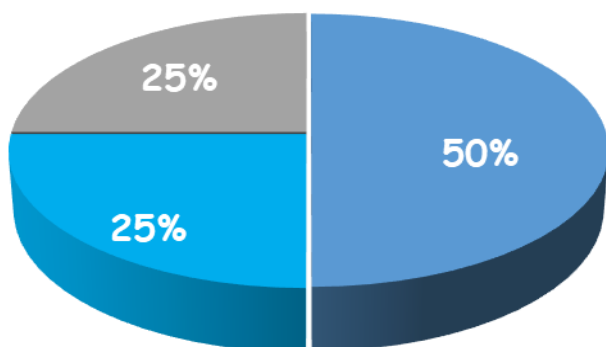


'19-'20 ANNUAL REPORT

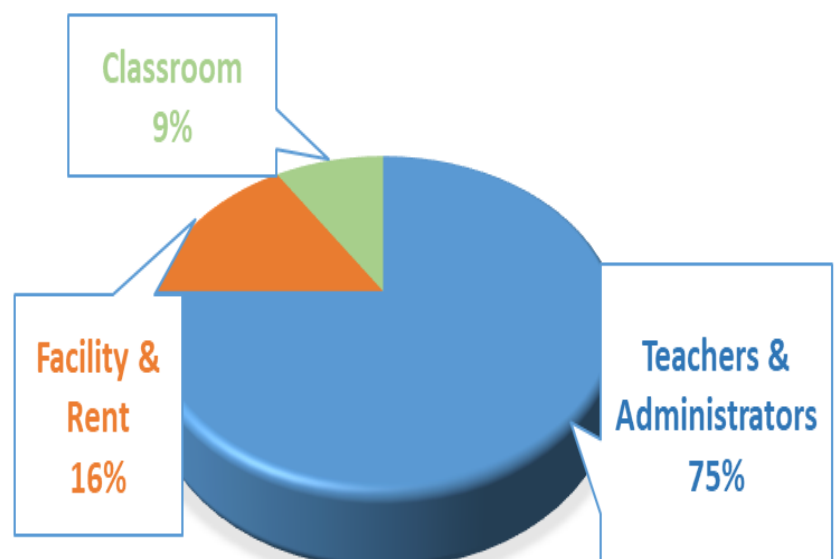
While we were not able to have the annual fundraiser last year due to COVID, in a typical year, about half of our fundraising dollars go to scholarships to support children of our staff and families from our community. About a quarter of what we raise helps pay for staff education as they continue to strengthen their understanding of child development through degree and training opportunities. The remaining funds go to facility improvements as we continue keeping the school looking fun and fresh for the kids.
